As part of this VMG as well, we discussed and defined the structure for a journal paper on the topic of business intelligence and how one can improve transparency and reporting of outputs of AI models with Linguistic Summaries.

The main outcomes of the virtual mobility grant were

- 2) beyond what proposed in the original, we produced another conference paper, that will be submitted at ICEIS 2024 conference, it can be found attached to the report
- 3) we set the basis for a journal paper, that will be written consequently with the involved partners, and that will discuss on a wider scale possible approaches for application of the linguistics summaries in financial domain, as well as critically discusses criteria for success as well as possible obstacles for implementation,

The work will be regularly presented at COST action activities, and a podcast will be created to further disseminate the COST action activities to wider audiences.
